


Why join University Hospitals?

As health care providers, we know a proactive approach is key to staying healthy. Our programs support prevention and getting the care you need, when you need it.

MEDICAL AND PHARMACY PLAN COVERAGE

UH offers three medical/prescription drug plan options: A Preferred Provider Organization (PPO) Plan and two High Deductible Health Plans (HDHP).

Traditional Choice (PPO)

No up-front deductible to meet for your medical services

- Medical care is covered by the plan from the start*
- Protection from high out-ofpocket medical expenses due to a significant health issue or injury
- Option to open a Healthcare
 Flexible Spending Account (FSA)

UH OFFERS ON-DEMAND VIRTUAL CARE THAT WORKS AROUND YOUR BUSY SCHEDULE.

We know residents juggle a lot. We offer cost-effective on-demand virtual care—including a low-cost email visit (e-visit) option for certain routine conditions.

HEALTH SAVINGS ACCOUNT (HSA)

The two HDHPs are paired with a tax-advantaged HSA. An HSA allows you to set aside tax-free money to offset the cost of eligible medical expenses and provides financial protection—now and in the future.

When you open your HSA, UH will contribute dollars too! If you elect the:

- Consumer Choice plan: Up to \$700 per person/\$1,400 per family per year
- Healthy Choice plan: Up to \$250 per person/\$500 per family per year

DENTAL AND VISION PLAN COVERAGE

Caring for your smile and eyes is key to a healthy you. We offer:

- Two dental plan options: Coverage for preventive, basic and major services, and orthodontia.
- Vision plan: Coverage for routine eye exams, prescription eyeglasses (lenses and frames) and contact lenses.

HSAs offer triple tax savings! You are not taxed when you:

- 1. Contribute money
- 2. Earn interest
- Spend money on eligible health care expenses—now or in the future

UH RETIREMENT PROGRAM


We want you to build a financially secure future. UH supports your retirement savings through the 403(b) Retirement Plan with a matching contribution—50% on the first 6% of pay you contribute after your first year of employment.

DEPENDENT CARE FLEXIBLE SPENDING ACCOUNT

Set aside pre-tax money to pay for eligible dependent day care expenses (for eligible children or elderly parent) while you or your spouse work, seek work or attend school full-time.

LAUREL ROAD

Receive special rates and incentives for residents on services such as student loan refinancing, mortgage lending and refinancing, tailored checking and savings accounts, and personal lending.



Financial Protection

Guard against the unexpected with financial protection benefits from UH.

LIFE INSURANCE

In the event of a death or injury due to an accident:

- Basic Term Life Insurance, including Accidental Death and Dismemberment (AD&D): Two-times (2x) annual salary—100% paid by UH.
- Supplemental Life and Voluntary AD&D insurance: Purchase additional protection for yourself, your spouse and your dependents.

SHORT-TERM AND LONG-TERM DISABILITY

In the event of an extended illness or injury, UH offers basic and voluntary:

- Short-term Disability: See the Residents Manual for details.
- Long-term Disability: Replaces a portion of earnings if unable to work.

UH supports you in your time of need—basic Short-term and Long-term Disability for full-time residents are 100% paid by UH—no cost to you.

FAMILY GROWTH BENEFITS

Support for your family planning needs:

- Paid maternity, paternity and adoption leave: To recover from birth and care for a newborn or newly adopted child. Refer to the policy for pay details.
- Reproductive health benefits: Coverage options include egg and embryo extraction for freezing, sperm extraction for banking, IVF, vasectomy reversal and more.
- Adoption assistance: Reimbursement is provided for certain qualified expenses for the legal adoption of either a single child or a sibling group.

SENIOR CARE AUTHORITY

Caring for an aging parent or elder family can be difficult. Senior Care Authority (SCA) provides support with placing an elder family member in a care facility, coaching services to guide you through tough conversations with loved ones, assistance with navigating legal needs and more.
